Candidates with Ph.D/M.Sc Agriculture (in any discipline) / Computer Science with 4 years/ 5 years of bachelor's degree with first division or 60% marks or equivalent overall grade point average and with atleast 3 years of research experience are eligible. Preference will be given to the candidates having law degree and experience of IP and Technology management/ IP portfolio/ data management/ IPRs and other related issues.
