- (3) This Institute is having DSIR concessional certificate and can be availed GST at concessional rates i.e. 5 % for which the prescribed concessional certificate will be furnished along with the payment. However, all applicable taxes will be paid at acutals as per Government of India rules from time to time.
- (4) Excise duty is fully exempted for this Institute and a copy of exemption certificate will be issued upon request from the firm.
- (5) The supplies should be made at the earliest through your local stockist/local dealer nearer to us, on priority basis allowing F.O.R. DESTINATION, irrespective of the monitory limits of the orders placed by this Office and our Regional Research Stations.
- (6) Minimum two/three Names & addresses of your stockiest/dealer nearer to us may also be informed for effective supply of your products.
- (7) Transit Insurance charges if any, have to be borne by you.
- (8) Your proposal along with price list for the year 2024-25 may be submitted to **this** office on or before 25.07.2024.
- (9) In case of any price reduction during the contract period, the same may be pass on to the customer.
- (10) The proposal received without price list will not be considered.
