F.No. TS-II(05/2018-Estt.IV, dated 30<sup>th</sup> May, 2018, if, at any time, it is found that the above employee is not possessing the requisite qualifications required for the respective grade or is not eligible to hold that grade for any administrative reason, then he/she is liable to be placed in the eligible lower grade and recovery of proportionate amount of dues can be made from him/her by giving a show-cause Notice.
