The EMD amount will be refunded after finalization of sale proceedings. (ii) The interested bidders may please note that (i) Bid for ONE tractor then, EMD amount of Rs. 10,000/-, (ii) Bid for TWO tractors, then EMD amount of Rs.20,000/- & (iii) Bid for THREE tractors, then EMD amount of Rs. 30,000/- shall be submitted. (iii) Quotation received without Demand Drafts towards EMD will not be accepted.

7.	Bids/Quotations should be dropped in the Tenders Box, kept at the Office of CTRI, Rajahmundry not later than due date and time. Bids/Quotation can also send by Registered Post. However, it is responsibility to reach the bids within the due date and time. Bids received after due date and time shall not be considered under any circumstances.
8.	The Bidders can inspect the items at the office of ICAR-CTRI, Rajahmundry/Katheru on any working day from 09:30 AM on 08.09.2020 up to 01:00PM on 28.09.2020.
9.	The bidders has to submit the Bid / Quote for tractors as per prescribed format. The rates may be quoted figures and words as well. If there is any discrepancy in figures & words, the rates quoted in rates will be considered for evaluation. The bidders are not allowed to withdraw their bids. If any bid is not readable that will be out rightly rejected.
10.	The bidder and their representative (not more than one) may remain present if they so desire at the time of opening of quotations.
11.	The bidders are not allowed to withdraw their bids, in such cases their EMD will be forfeited.
12.	The bidder quoting higher rates will be selected for awarding sale order.
13.	The bidder has to submit copy of PAN card or Aadhar card in case of individual and Registration Certificate & copy of PAN, in case of firm, along with duly filled Bid format within due date & time.
14.	The successful bidder has to pay the total bid amount in full though swiping or Demand Draft in favour of ICAR UNIT : CTRI payable at Rajahmundry on receipt of award of sale order within 15 days. In case of non-payment within the prescribed period the EMD of successful bidder will be forfeited and no correspondence in this regard will be entertained.
15.	On receipt of full payment only, this office will give permission to move the old tractors. The successful bidder has to make necessary arrangements to move/transport the old tractors from this office at his own cost / expenses, within 15 days from the date of sale order.
