This plant has more than 18 secondary metabolites which are responsible for curing of many human ailments like nerve problem, cancer, skin problems, diabetic, etc.

With this background, ICAR-CTRI (ICAR-NIRCA) and MANAGE are organizing a 4-days online training program on "Good Agricultural Practices, Value Addition and Marketing of Ashwagandha – Potential Commercial Medicinal Plant" through online mode during 15-18, MAY 2023.

- 11. Marketing, digital marketing, business development and export opportunities in ashwagandha
